

## VALUABLE INFORMATION FROM THE OCTOBER 16 MEETING

Program VP **Joanna Crane** introducing speaker **Debbie Diener**.

Attendees at the October 16 Branch Program were fascinated by the speaker's perspective on our vulnerability to scams, identity theft, and invasion of privacy that is now occurring in our digital age.

**Debbie Diener**, who writes and blogs on "*Staying Safe in the Digital Age*," is an attorney and an experienced professional in the area of digital privacy. She has worked with both government agencies and private industry on issues related to the topic. She gave examples of our most vulnerable situations and current scams. Her message to the group was that they must be cautious and pro-active to protect themselves and "never hesitate to change your card when you feel uncomfortable that your information may have been compromised."



## **REPORT FROM THE NORTHERN DISTRICT MEETING**

At the annual **Virginia Northern District Meeting in Burke on October 18**, a fascinating panel of women experienced in the political process—either as campaign manager or candidates in Virginia elections discussed their insight and experience. They revealed their own personal motivation for political involvement, experience with fundraising, challenges, and sources of strength as candidates for public office. All agreed that women in politics have particular hurdles related to money and the perception of women's capabilities to govern.

Melissa Jackowski, the panel moderator, has had extensive experience as campaign manager and fundraiser for various political candidates. Jeanette Rishell is active in local Manassas politics. She now serves on the Manassas Park City Council and is contemplating a run for mayor next year. Margi Vanderhye, now serving as Executive Director for the Virginia Commission for the Arts, has served in various appointed political offices and served one term as State Representative in the Virginia State Assembly. She waged an unsuccessful campaign against Barbara Comstock in the last election, which she lost by only 365 votes. Both Margi and Jeanette praised Emily's List as a source of financing and mentoring.

**Patsy Quick** described the Virginia State AAUW Project "From Vision to Reality—Mission Possible" that was introduced at the Summer Leaders Meeting in July.

**Caroline Pickens** discussed early plans for the Virginia State Conference, which will be held in Northern Virginia in 2016. All Northern District branches will have assigned duties for the 2016 conference.

Other items of note from the meeting:

The 2015 State Conference will be held in Charlottesville on April 18-19.

AAUW State Lobby Day is February 4, 2015, and Federal Lobby Day is May 7, 2015.

Webmaster **Leslie Vandivere** encouraged members to visit the **AAUW Facebook** website and to like and/ or share it.

Three state positions are open: Membership VP, Finance VP, and Recording Secretary. Nominations are to be submitted by December 1, 2014, to Caroline Pickens.

# SIGN THE HUMAN TRAFFICKING PETITION

Human trafficking is an international disgrace. It forces an estimated 27 million people worldwide into prostitution or involuntary labor. The Polaris Project, which tracks federal and state laws on human

trafficking, recommends that Virginia pass laws to provide assistance to human trafficking survivors, including creating "safe harbors" for sexually exploited minors. We want to make sure our Virginia lawmakers in Richmond know this-and do something about it.

We have embarked on a petition drive and need the support of all our branches to ensure success.

Although our goal is to collect

1000 signatures, we should be able to collect many more signatures through our collective "woman power." After all, we have until January 30, A copy of the petition will be at the next Mt. Vernon 2015, to collect signatures.

The petition reads:

We the Undersigned join with the American Association of University Women (AAUW) in urging you to support legislation improving assistance for human trafficking survivors in Virginia.

Human trafficking is a modern-day form of slavery that forces an estimated 27 million people worldwide - including people in the United States- into prostitution or involuntary labor.

> The National Human Trafficking Resource Center reports that it received 742 phone calls from individuals seeking help in Virginia in 2013 — the sixth highest number of calls among all states and Washington, D.C. that year.

#### **Questions on the Ballot:**

#### PROPOSED CONSTITUTIONAL AMENDMENT:

Property tax exemption for certain veterans and surviving spouses of soldiers killed in action.

**Ballot Question:** Shall Section 6-A of Article X (Taxation and Finance) of the Constitution of Virginia be amended to allow the General Assembly to exempt from taxation the real property of the surviving spouse of any member of the armed forces of the United States who was killed in action, where the surviving spouse occupies the real property as his or her principal place of residence and has not remarried? YES/NO

#### TRANSPORTATION BONDS:

Shall the Board of Supervisors contract a debt, borrow money and issue bonds of Fairfax County, Virginia, in addition to bonds previously authorized for transportation improvements and facilities, in the maximum aggregate principal amount of \$100,000,000 for the purpose of providing funds to finance the cost of constructing, reconstructing, improving and acquiring transportation facilities, including improvements to primary and secondary State highways, improvements related to transit, improvements for pedestrians and bicycles, and ancillary related improvements and facilities? #### **NEED A PHOTO ID??**

You must be a registered voter in Virginia. You may register online, then apply for a photo ID. You may register in person and apply for a photo ID at the same time. Either way, the photo ID will be mailed after the registration is confirmed. Voters without a photo ID can cast a **provisional** ballot, then get a temporary photo ID at the Elections Office or bring, mail, e-mail or fax a copy of an acceptable photo ID by **noon Friday**, **November 7**, to have their ballots counted.
