MANDATORY BYLAWS REVISIONS

The branch received an email, **"PRIORITY AAUW Mandatory Conformance Memo"** ("conformance memo") on August 10, 2015, from **Patricia Fae Ho**, AAUW Board Chair. It explained that the 2015 AAUW bylaws amendments (that were voted on and approved by the nation-wide membership) require mandatory amendments to all branch bylaws. The mandatory amendments should have no impact on the day-to-day operations of the branch and do not need a vote of the branch membership.

The conformance memo provided instructions for the amendments and stated that they were due to national on or by May 15, 2016. The state bylaws chair sent a follow-up email with specific instructions to all branches and asked the branches to submit their proposed amendments to the bylaws chair by March 15, 2016. The state bylaws chair will review and approve the branch bylaws amendments for submission to national.

However, on October 29, **Patricia Fae Ho** sent all branches an email entitled, **"AAUW Model Bylaws for States and Branches"** ("Model Bylaws Memo"). It included a set of model bylaws for branches. The memo said it provided them in response to many members' requests for model bylaws, and that the model bylaws will simplify the integration of the changes requested by the conformance memo. The memo encouraged the branches to adopt the model bylaws whole-sale and then customize and fill in the gaps as needed.

The model bylaws are significantly different from the current branch bylaws. For example, the model bylaws include a section on "State or Multistate Organizations" that is not currently present in our branch bylaws. The state bylaws committee is reviewing the model bylaws and will provide guidance to all branches.

Joanna Crane, State Bylaws and Resolutions Chair, has taken the lead on amending our branch bylaws, and would welcome assistance and input from anyone who is interested.

PUBLIC POLICY AND KUDOS

The following is a recent email from Leslie Tourigny, State Vice President for Public Policy. It includes information that you all need to know and also a kudos for our branch.

First of all, we have gotten off to a great start with Get Out the Vote activities. As best as I can determine, we are almost a third of the way towards meeting our goal of registering 1000 voters by the November 2016 Presidential Election. To be precise, we have registered 318 new voters. Thanks to the Greater Richmond, Mount Vernon, Newport News, Norfolk, Portsmouth, Virginia Beach, and Wytheville branches. Once again, a special "shout-out" to the Newport News branch for registering almost half of these voters. At this rate, we should be able to far exceed our goal by November 2016.



- 2. Presidential Primary Election Day in Virginia will be March 1, 2016, and Tuesday, February 8, 2016, is the last day on which a person may apply to vote in the Presidential Primary. This gives us another large window of opportunity to register lots of voters.
- 3. Also, **AAUW of Virginia** officially partnered with the League of Women Voters-Fairfax Area, as well as Zeta Phi Beta Sorority, Fairfax County Council of PTA, and the Voice of Vietnamese Americans to hold a series of Candidate Meet and Greet Events leading up to the General Election in November. **Kudos to the Northern District branches who volunteered time and money to make these events so successful**.
