Be Proud of what AAUW Accomplished in 2016, Do More in 2017!

According to a post on the national AAUW website, "Look What AAUW Action Network Accomplished in 2016!," last year was a terrific year for AAUW's advocacy efforts. The list below, taken from the article, shows just some of what AAUW accomplished last year. In 2016:

- * 6 states passed new equal pay laws, with AAUW members playing a key role.
- * 19 AAUW members were elected to state legislatures or state senates.
- * **900+** get-out-the-vote events were organized by members in 46 states.
- * **2,200** signatures were collected on AAUW's petition urging Anheuser-Busch to sign the White House Equal Pay Pledge. Just three months after the pledge was released on Women's Equality Day Anheuser-Busch signed the pledge.
- * **200,000+** messages went out to state and federal legislators. AAUW Action Network members in all 50 states made their voices heard. We contacted all 435 U.S. House offices and all 100 U.S. Senate offices throughout the year.

AAUW's nonpartisan voice and advocacy are needed now more than ever. Our branch can be proud of the generous support we provide to AAUW. To ensure that AAUW continues to have numerous successful policy initiatives in the coming year, we increased our branch's 2017 donation to AAUW Funds by 50% over last year's total!

EARLY LEARNING CENTER, NEXT STEPS FOR OUR BRANCH



UCM's **Early Learning Center (ELC)** greatly appreciated the nap rugs, hand knitted blankets, new and gently used books and art supplies the branch contributed at our holiday luncheon. UCM has recognized our contributions by featuring us as a community partner in its <u>January newsletter</u>. Now we as a branch have to decide what's next over the next one-to-two year period.

At the Annual Meeting in March we will discuss options, which include the following:

- 1. Read to preschoolers or infants (or just interact with infants). For preschoolers 9 am -12 pm or 3 6 pm are the best times; for infants, any time. Beyond this, the ELC is totally flexible about how much or how often volunteers come. (Note: you have to have a TB test and a criminal background check to work with children).
- 2. Put on a breakfast for ELC's teachers during Teacher Appreciation Week in May. Perhaps give small gifts.
- 3. **Donate art supplies and books at least once a year** (books, art supplies, etc.), say at our Christmas brunch.
- 4. **Provide gardening assistance.** We could do a project with kids, or meet on a Saturday and plant kid-safe flowers and vegetables that we donate for the beds outside the main entrance and children's playground garden; pressure wash or pay for pressure washing of the Playground.
- 5. **Make doll clothing** for the classroom dolls that lack clothes!

6. <u>Donate opened materials/recyclables: toilet & paper towel rolls, egg cartons, shoe boxes etc.</u> They use these for art projects. This is something we can implement right away. **Please bring these items to the Annual Meeting in March.**






















LTA FUNDRAISER COMING SOON!

Teach-In on Women's Rights by Politics and Prose, a bookstore and coffeehouse.

A review by Elizabeth Lonoff:

The day before the Women's March on Washington, Politics and Prose held an overflowing Teach-In on Women's Rights in response to customers seeking refuge for honest discourse about American values. The series continue with climate change, immigration, and the future of political parties. Reading lists will be posted for each topic

Responses to moderator and audience questions:

- Election reflects lack of social attitudes for character threshold, complacency, and backlash to shifting social values and pressure for white men to share power. Visible sign of barriers people thought were gone. New policies will disproportionately harm/setback women. LGBT data is gone from federal websites. People need to pay attention and show up at town meetings.
- Women's March reflects diversity and interconnected issues. Since women are in the majority, U.S.

- feminism needs an inclusive message to move forward through conversations into some way of persuasion, seeking common ground on economic and national security issues.
- Under assault immediate risk to civil rights through regulatory action, budget cuts, and legislative priorities; long-term erosion of diversity in federal workplace and cuts to safety-net programs; lost opportunities by not taking action or taking inadequate action for equal pay, global economic participation, childcare access, and paid maternity leave.
- Areas for progress grassroots and young-voter organizing; supporting state and local initiatives; training and helping good local politicians to go further; listening and debating.
- Everyday acts of feminism if you see something wrong, say something; become politically active; stand up for each other; see where you can contribute the most.

Virginia students won't give back their hard fought Title IX victories

As we begin a new year with a new administration, it's appropriate to reflect on the past success of Title IX of the Education Amendments of 1972 and hope that future Title IX enforcement will be as robust.

Since signed into law by President Richard Nixon, Title IX has had the support of both Republican and Democratic administrations. It has enabled a generation of women and girls to realize educational opportunities, especially in athletics, which were previously denied to women. However, the priority we place on schools complying with Title IX today did not happen overnight — it took decades after the law was passed to see real change.

As a member of the American Association of University Women of Virginia, an organization that has worked to ensure gender equity in education for more than 135 years, including through the passage of Title IX, I want to thank the Office for Civil Rights (OCR), the enforcement arm of the U.S. Department of Education, for what it has accomplished over the past eight years, and to share why students will always need an energetic and fully-funded OCR.

For decades, students struggled to get OCR to enforce long-standing statutes, regulations, and Supreme Court case law concerning sex discrimination in education — including how schools handle cases of sexual harassment and violence. Time and time again, students — especially women, girls, and LGBTQ students — had to go to court when they faced sex discrimination in education. Although Title IX was law, there was little appetite to expand the resources necessary to make the law meaningful. Some think that the responsibility schools have to address sexual harassment and violence is "new," when in fact a 1992 Supreme Court unanimously ruled that students who are subjected to sexual harassment in public schools may sue for monetary damages under Title IX. Others think the 2011 OCR guidance on sexual violence and Title IX was "new"

when in fact both **Presidents Bill Clinton** and **George W. Bush** issued similar guidance on sexual harassment. So what is "new"? Public awareness, increased technical assistance for schools, and enforcement.

Since 2009, we've seen OCR respond to a student movement that demands Title IX enforcement beyond athletics. OCR heard the demands from students to better address sexual violence and hostile climates and helped with school Title IX compliance. When students were severely harassed in school, some to the point of committing suicide, OCR intervened. When schools asked for help in finding ways to accommodate pregnant and parenting students as well as ensuring equal access to career and technical (CTE) programs, OCR provided guidance. Title IX coordinators finally received a detailed description of their responsibilities thanks to OCR. All of these successes occurred, despite limited staffing levels, and an everincreasing caseload. In fact, in FY 2016, OCR resolved 1,346 Title IX complaints — that's 1.5 cases per hour!

OCR recently released a report that documents its work over the past eight years. It shows what students and advocates already know — under Assistant Secretary **Catherine Lhamon's** leadership, OCR's work led to better outcomes and safer climates for countless students nationwide.

OCR plays a critical role every day in assisting schools to better implement Title IX and deal with violations of students' civil rights, which can seriously threaten a student's access to an education. Let's remember a robust OCR is vital to ensure schools and colleges have the assistance they need to proactively implement and comply with Title IX. Their success shows we must remain vigilant and that students and advocates will continue to need a strong ally in OCR.
