

PATSY QUICK



Wilma Jones is a top-performing director in corporate information technology sales, popular keynote speaker and workshop leader, self-published author and award-winning community activist. Wilma Jones is a dynamic force in a variety of pursuits. An engaged civic activist, Wilma is serving her fourth term as president of the John M. Langston Citizens Association.

Wilma's third book, <u>My Halls Hill Family: More Than a Neighborhood</u> is a historic memoir of the neighborhood she grew up in and still resides in today, Halls Hill. As a fourth-generation resident of Halls Hill, which was a completely African-American community until the 1970's, the book is her attempt to save at least some of the community's stories. To the many people who grew up there, visited family there or even spent time there, Halls Hill was more than a neighborhood. On February 2, 1959, Wilma's brother,

Michael Jones, was one of four Black students to enter Stratford Junior High School. They were the first students to desegregate any public school in Virginia.

Brenda Mitchell-Powell earned her Ph.D. from Simmons University in Archives Management as an American Library Association (ALA) Spectrum Fellow in 2015. Currently an independent scholar and researcher, Dr. Mitchell-Powell served as a contributor, writer, editor, reviewer, and consultant for several national and international publications, as well as for city, state, and federal agencies, literary councils, publishers, cultural organizations, and professional associations.

Her essays on Black history and culture and her reviews of educational materials, literary titles, children's books, and library resources have appeared in a variety of trade and professional publications. Her book, <u>Public in Name Only: The 1939</u> <u>Alexandria Library Sit-In Demonstration</u>, published in 2022, focuses not only on the struggle for desegregation in Alexandria but also provides an overview of the Jim Crow laws, their impact, and the legal battle to defeat them.

OUR PROGRAM SPEAKERS

When Alexandria, Virginia's first public library was constructed just a few blocks from his home, Samuel Wilbert Tucker, a young, Black attorney, was appalled to learn that he could not use the library because of his race. Inspired by the legal successes of the NAACP in discrimination cases, he organized a grassroots protest to desegregate the library that his tax dollars supported.

<u>Public in Name Only</u> tells the important, but largely forgotten, story of Tucker and a group of Black citizens who agitated for change in the terms and conditions of their lives. Employing the combined strategies of direct-action public protest, nonviolent civil disobedience, and municipal litigation, Tucker's initiative dovetailed with the national priorities and tactics of larger civil rights organizations. While Tucker's campaign did not end with the desegregation of the Alexandria Library, but instead resulted in the creation of a "separate-and-unequal" Jim Crow Black branch, the sit-in demonstration represented a momentous early struggle for racial equity waged through civil rights activism.

PAID SICK LEAVE FOR ALL WORKERS





After receiving an M.A. in Science, Technology and Public Policy from George Washington University, she worked for a few years in private industry before launching her Federal career at the National Science Foundation.

As the Program Manager for the Federal Sector of Energy Star Buildings at the U.S. Environmental Protection Agency, she directed the first program to benchmark and evaluate Federal buildings for energy and indoor air performance. As the Chair of the Federal Interagency Sustainability Working Group at the U.S. Department of Energy, she spearheaded the

first Federal Sustainability Memorandum of Understanding, signed by 26 Federal Agencies, culminating in the first Federal Executive Order for Sustainability. Beverly successfully completed the Senior Executive Development Program before retiring after 32 years of Federal service.

Beverly is married to retired scientist, Bob, has two adult stepchildren and one granddaughter. Favorite pastimes include swimming, sailing, kayaking and hiking; reading; listening to Classical, bluegrass, and rock music; and playing the piano. She returns to Cape Cod each summer to swim, eat lobster and enjoy the cool summer breezes.



Suzanne Cleary

Suzanne Cleary is a former executive speechwriter, strategic planner, marketing communicator, advertising writer, and financial writer. In California, she began her career at CP National, where she did conservation advertising and edited the company newsletter. In the Washington, DC area, Suzanne worked for Potomac Electric Power, C&P Telephone and Bell Atlantic. As an independent marketing consultant, she worked for Verizon, AARP and the NASDAQ Stock Exchange, among others. She also managed the marketing and advertising for Virginia's successful Tax Amnesty Program and has won multiple awards for her work.



• Diana Parsell, author and member of the AAUW McLean Area Branch, will introduce us to *Eliza Scidmore, the Early AAUW Member Behind Washington's Cherry Blossoms.*

As Diana's book reveals, Scidmore was an extraordinary journalist and travel writer who got her start as a newspaper correspondent in Gilded Age Washington in the 1870s. She wrote authoritative books on Alaska, Japan, Java, China and India; was an activist in the burgeoning U.S. conservation movement, in association with major figures like John Muir; and was the most influential female at the early National Geographic, as the first woman elected to the board (in 1892) and to publish photographs in the magazine. In 1920, Scidmore became an AAUW member. Copies of the book will be available for sale.
